

# Gene Douglass for Congress – NC #2

## AUTOBIOGRAPHY OF EUGENE F. DOUGLASS

I was born and raised in the suburbs of Philadelphia, Pennsylvania. My mother was an elementary school teacher and my father worked for DuPont and later became a College Instructor/Administrator in Engineering. I attended The King's College in Briarcliff Manor, NY where I majored in Chemistry and Math. During the summers of 1975, 76 & 77, I was a member of the Teamsters Union as a Cab Driver in Philadelphia. I graduated in May 1979. I then went on to graduate school in Chemistry, first to North Dakota State University, and then to the University of Connecticut in Storrs, where I got my MS degree in 1982. In 2010, I completed my PhD in Fiber/Polymer Science at NCSU.

After my first MS degree, I worked for a few years in industry as a Chemist, and then went back to school for a theological degree. I received my M.Div. from Bethel Theological Seminary in San Diego, CA in 1989. We moved to Hawaii in August of 1997, after finishing a two-year contract teaching at the College of Micronesia - FSM, in the Federated States of Micronesia, on the island of Pohnpei. I then taught Chemistry in Hawaii, New Hampshire, Pennsylvania, North Carolina, Kazakhstan, Iraq, South Texas, South Carolina, and now I am a retired Chemistry and Education consultant.

### My Political Experience:

I ran for the US Senate in 1998, getting third in a field of nine for the Republican Nomination. I served as Campaign Director for my wife Carol, who went on to win the Republican primary and ran in the General Election as the Republican Nominee for US

House District #2 for Hawaii. We then did the same in 2000, also in Hawaii, me coming in 2<sup>nd</sup> out of 4 candidates, and my wife coming in second to the winner of the primary. We then moved to New Hampshire, where I decided to run for the US House in District #2, against a liberal Republican Rep. Charlie Bass, the congressman at the time who did not support President Bush's efforts on ending partial birth abortion. He won the primary, and then I endorsed him for his later win against Katrina Swett, to retain the House seat for the Republican party. After then, I withdrew essentially as candidates, concentrating on my college teaching.

When I retired, sold my house in Robeson County, I moved up here to Wake County, and realized my district has a liberal feminist representing all of us. And after seeing the great movie, Sound of Freedom, at the theater, I took up the challenge and decided to try to remove her from Congress in 2024.
