## **Scope**

The Office of Secure Transportation's (OST) Research and Analysis Division (RAD) continues to evaluate the potential threat conspiracy theories present to OST personnel and missions. This Reference Guide offers a description of various conspiracy theories to be found on social media and in other corners of the Internet. RAD will note those conspiracies which have presented, or may present, a potential threat to OST through misidentification or operational proximity.

The reader should note the multitude of conspiracy theories, and varied versions thereof, make it nearly impossible to fully catalogue in a single document. Further, the reader may find a particular version of a conspiracy theory written from a different perspective with varied information. The goal of this document is not to lock the reader into a particular conspiracy narrative or version; but to provide the reader with an understanding of the main themes driving conspiracy true believers.

## Introduction

The term “conspiracy theory” invokes thoughts of secretive government agents, agencies, and events that exist outside of the general public’s understanding or control. Conspiracy theories often stem from real events; however, the narrative around real events may be manipulated to fit the narrative of existing conspiracy theories. The result is a newly interpreted reality where conspiracy theorists, those who follow and interpret conspiracy theories, reject official information from the news media and/or governmental leaders in favor of a “conspiracy” to explain the reported events.

Conspiracy theorists (also referred to as “conspiracists”) generally reject “mainstream” information. “Question everything” is a phrase often quoted and leads conspiracists to seek alternative sources of information. These alternative information sources often push unverified or erroneous information and can be deliberately misleading.

Conspiracy theories have led to violence. In recent years, several mass shootings have either been directly attributed to conspiracy theories or contained elements of conspiracy theories. In 2018, Robert Gregory Bowers<sup>USPER,1</sup> posted online conspiracy theories about Jews before he killed 11 people at a Jewish Synagogue. In November of 2013 Paul Anthony Ciancia<sup>USPER</sup> shot and killed a TSA agent. Ciancia carried a confession letter which spoke of his disdain for the New World Order.<sup>2</sup> In 2016, Edgar Maddison Welch<sup>USPER</sup> entered a pizza parlor in Washington, D.C. with multiple weapons, looking for a child sex trafficking ring tied to high profile Democratic leaders that was said to operate from a basement in the restaurant.<sup>3</sup> The basement did not exist.

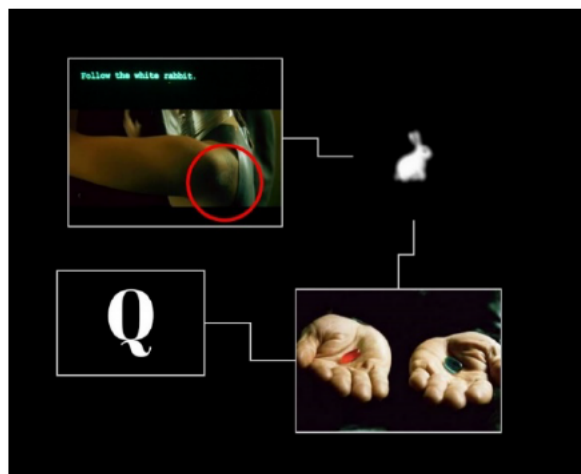
During the writing of this document, a riot ensued in Washington, DC on January 6th, 2021. The rioters, also referred to as insurrectionists, fought with police and forced their way into the US Capitol building looking for certain VIPs, including then US Vice President Pence<sup>USPER</sup>. Some rioters were armed with firearms and some were carrying flexi-cuffs. One police officer died, and one protestor was shot and killed by police during the event.

Conspiracy theories have direct and indirect implications for OST. In 2015, OST vehicles were incorporated into the JADE HELM conspiracy which stated the government intended to use a military exercise named JADE HELM to conduct a military coup of the United States. OST vehicles were perceived as part of the military forces preparing to carry out this attack. In July 2018, the ongoing Area 51 conspiracy theory, which states extraterrestrials, alien bodies, and/or alien technology are contained at Area 51, drew several thousand people to Rachel, Nevada for “Alienstock.” Participants indicated they intended to “storm the gates” with the intent of finding evidence to prove the conspiracy true. OST sent a contingent of agents to support the security effort at DOE’s Nevada National Security Site. In 2019, OST vehicles were misidentified as Immigration and Custom Enforcement vehicles, “ICE trucks,” responsible for transporting children from the border to various immigrant detention facilities. While OST did not experience complications due to the misidentification, an ICE detention facility was attacked in Tacoma, WA in July 2019. The manifesto of the attacker indicated he was acting in defiance of “concentration camps.”

The multitude of emerging conspiracies, along with the number of permutations of existing ones, ensures OST will yet again be misidentified. The sections below discuss various conspiracy narratives in existence and the potential, if any, for OST to be included as part of a given conspiracy.

# 1

## A Brief Description of the Conspiracy Universe



Conspiracy theories thrive in the gaps of knowledge and understanding. The stories created to explain complex historical events are often complicated and convoluted. Once these narratives take hold, they are difficult, if not impossible, to displace.

Conspiracy theories are a fixture in American story telling. Television shows such as *In Search Of* and *X-Files*, along with major motion pictures such as *Enemy of the State* provide conspiracists an array of narratives; most notably of an all-powerful and secretive government monitoring a mysterious universe, while simultaneously misleading the citizenry.

Conspiracy theories possess their own lexicon. Although each conspiracy possesses its own glossary, the “conspiracy universe” has developed a set of commonly used terms to be found in most, if not all, conspiracy forums. Below is a sample of these terms:<sup>i</sup>

- **The Matrix:** “The Matrix” originates from *The Matrix* franchise and refers to human civilization. As in the movie, conspiracy theorists claim the world in which we live is a deliberately misleading construct, aimed at controlling and, ultimately, subjugating the citizens into slavery.
- **Exiting the Matrix:** When a person chooses to reject the description and history of the world around them as a deliberately and maliciously misleading construct; and who then seeks to know the truth of “reality” through conspiracy theories.
- **Red Pill:** This term also stems from *The Matrix* and is used to mean choosing to look at the information provided by conspiracy theorists to expose the recipient to “the truth.” A person who accepts the conspiracy narrative and seeks further information has been “red pillied.”
- **Awake/Woke:** A slang term used to describe a new state of awareness, usually referring to social issues. Social activists across the political spectrum also use these terms.
- **Blue Pill:** Choosing to accept the world as presented since birth and “remain asleep.”
- **Follow the White Rabbit:** While originating from the book *Alice in Wonderland* by Lewis Carroll, current use of the term draws its influence mostly from *The Matrix*. The term means to follow a clue to a greater “truth.” When used while discussing conspiracies, the “truth” is the conspiracy and its explanations of a new reality.
- **Down the Rabbit Hole:** Originating from the book *Alice in Wonderland*. The term refers to following the path of clues to a greater “truth.” When used while discussing conspiracies, the “truth” is the conspiracy and its explanations of a new reality.

- **Shill:** A covert operative, usually representing a government, trying to steer perceptions and conversations favorable to one perspective on social media or another forum.
- **Sheeple:** Anyone who accepts the world as presented.

Differing conspiracies have similar structures and generally rely on the same emotional and psychological mechanisms. Although this document is not designed to be a discourse on the psychology of conspiracy theories, a few common psychological elements of conspiracies, along with some mechanical elements are briefly discussed below:<sup>ii</sup>

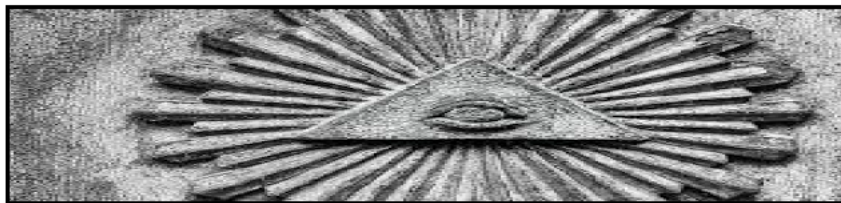
- **Issue or Event:** The trigger for a conspiracy narrative is usually a newsworthy event or ongoing social issue.
- **Denial:** The conspiracist will deny the reality of the event or issue. Events are usually labeled “False Flags,” and ongoing issues are usually labeled as “deliberate distractions.” Denial is not necessarily immediate; a conspiracist can be convinced to reject established narratives by other conspiracists at any time.
- **Evidence:** The conspiracist will then create evidence or fixate on evidence created by other conspiracists as proof of a conspiracy.
- **Explanation:** The conspiracist then creates an explanation of events or the intent of a social distraction; or the conspiracist accepts the explanation provided by other conspiracists.
- **Incorporation:** The new “truth” becomes part of the person’s vocabulary and worldly understanding. The conspiracy may become linked or incorporated into another established conspiracy.
- **Refusal of Counter Information:** Once the conspiracy has been accepted and incorporated, the conspiracist is usually resistant to counter information and may accuse the person providing the counterproof as part of the conspiracy.

The following chapters discuss specific conspiracies in detail. The above lists may assist the reader in understanding the multitude of social and psychological complexities accompanying conspiracy theories, and the challenges they present to law enforcement.

## The New World Order: Basic Elements

---

This reference guide begins with the *New World Order (NWO)* conspiracy. While other conspiracies exist pertaining to human history and societal design, the NWO appears to be the most widely recognized and accepted among conspiracists. From this single conspiracy, an entire taxonomy of narratives can be created, interpreted, and incorporated into a single “universe.”



The NWO is a term used by conspiracy theorists to describe the emerging global system. Its primary feature is a single over-arching government, believed to be the United Nations, which will essentially erase all national boundaries. With the erasure of national boundaries, national sovereignty would be removed. For many American conspiracy theorists, the loss of national sovereignty means the destruction of the US Constitution in favor of a system that will remove many of the rights now enjoyed by American citizens.

The NWO is believed to be tyrannical in nature. In every version of the NWO conspiracy, the one world system is authoritarian, cruel, corrupt, and serves only a single class of citizens: “the elite.”<sup>iii</sup>

While there is not a formal history of the NWO, conspiracists point to numerous historical events that serve as the foundation for this narrative. Below is a sample list of events some conspiracy theorists allege play a role in the emerging NWO:

- **The establishment of the Masonic Lodge:** According to the Encyclopedia Britannica, the first Masonic Grand Lodge was established in England in 1717. The lodge has ancestral ties to stonemason guilds of the Middle Ages and incorporates “the rites and trappings of ancient religious orders and of chivalric brotherhoods,”<sup>iv</sup> which directly contribute to the allegations of occult or satanic practices inside the lodges.<sup>iv</sup> Some Masonic conspiracies link the Freemasons and Illuminati,<sup>v</sup> and further claim Freemasons are the direct descendants of the Knights Templar.<sup>5</sup>
- **Creation of the Federal Reserve:** The Federal Reserve is viewed as the “overthrow” of the American dollar by international bankers, most notably J.P Morgan<sup>USPER</sup>, and the Rothschild<sup>USPER</sup> family. Control of the Federal Reserve will allow the bankers to subvert the American economy in favor of a global system.<sup>6</sup>
- **Creation of the League of Nations:** The League of Nations was a global body established after World War I. Its purpose was to provide nations a forum to communicate and resolve conflict before a major war erupted. The League of Nations is considered the precursor of the United Nations.<sup>7</sup>
- **Creation of the United Nations:** The United Nations is a central element of the NWO conspiracy. The cooperative body is viewed as the governmental body in waiting, which will rule the world, enforce laws, and de-arm citizens across the globe.

- **Removal of the United States from the “Gold Standard”:** Conspiracists claim a fiat currency allows a central bank, like the Federal Reserve, to deliberately place a nation in a cycle of perpetual debt, and under the control of international bankers.<sup>8</sup>
- **George H.W. Bush’s New World Order Speech:** In the aftermath of Persian Gulf War and the perceived evaporation of the global communist threat, President H.W. Bush<sup>USPER</sup> gave a speech to the United Nations Assembly in which he spoke of a “New World Order.” His comments were directed at the development of national economies, the ascension of international law, and “*Pax Universalis*.”<sup>vi 9</sup> Conspiracy theorists view this speech as a declaration of intent to begin the process of creating a one-world government.

Several international cooperative bodies exist that play a role in the conspiracy narrative including the Council of Foreign Relations, the Trilateral Commission, OPEC, the International Monetary Fund, and the World Bank. Events such as Presidential assassinations, treaties, wars, and even the moon landing may also play a role in the NWO, depending on who is telling the story.

## Elements of the New World Order


As stated above, the NWO conspiracy, as with many conspiracies, has many variations which differ in detail. However, each has some form of the following elements:

- **A Single Global Government:** The primary feature of the NWO is the single over-arching government which conspiracy theorists believe is emerging. The government is believed to be totalitarian in nature, superseding all other national sovereignties and laws. The global government will be protected by a global military and police force.<sup>10</sup>
- **One World Financial System:** The NWO will have a single world financial system and single world currency.<sup>11</sup> The financial system will be enforced through reserve banks across the globe.<sup>12</sup> This subplot has several variations to include accusations against “Zionist bankers”<sup>13</sup> and a cartel of international bankers using communism to create a single global financial system and “rule the world.”<sup>14</sup>
- **The United Nations:** The United Nations plays the role of bureaucratic system of the one world government and will serve a supreme leader.<sup>vii 15</sup>

**Decrees of the Georgia Guidestones**

- *Maintain humanity under 500,000,000 in perpetual balance with nature.*
- *Guide reproduction wisely — improving fitness and diversity.*
- *Unite humanity with a living new language.*
- *Rule passion — faith — tradition — and all things with tempered reason.*
- *Protect people and nations with fair laws and just courts.*
- *Let all nations rule internally resolving external disputes in a world court.*
- *Avoid petty laws and useless officials.*
- *Balance personal rights with social duties. Prize truth — beauty — love — seeking harmony with the infinite*
- *Be not a cancer on the Earth — Leave room for nature*

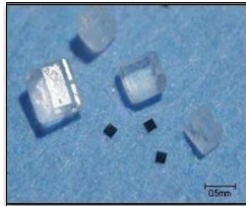
Figure 1: Georgia Guidestones

- **Agenda 21:** Conspiracists believe the “global elites” intend to reduce the human population by at least 90 percent.<sup>viii</sup> Conspiracists point to Agenda 21 of the United Nations which speaks of global sustainability, to include human population growth, as proof of their intent to reduce the population.<sup>16</sup> They also point to the **Georgia Guidestones**’ call for a human population “in perpetual balance with nature no more than five hundred million” (*Figure 1*)<sup>17</sup> Once the human population is reduced to manageable levels, the rest will be enslaved.<sup>ix</sup>

- **Radio Frequency Identification (RFID):** According to conspiracists, the NWO intends to “enslave humanity”<sup>x</sup> under a brutal and oppressive global government system.<sup>18</sup> An essential element of this conspiracy states every person will be forcibly issued a microchip that will be connected to a global communications system. The chip will allow the One World Government to actively monitor every citizen on the planet. Different variations of this theory include elements of 5G, bar codes, vaccines, and the “Mark of the Beast.”<sup>19</sup> The conspiracy has evolved over the years to incorporate new technology. At present, the emerging 5G cellular network is the alleged tool of the NWO’s RFID program. The origins of this conspiracy may go back hundreds of years, given the biblical aspects of this narrative.<sup>20</sup> More recently, conspiracists point to the UN’s ID2020 initiative which seeks to create a system where the entirety of Earth’s inhabitants have an individual, trusted, and verifiable identity as proof of the global RFID program.<sup>21</sup>

Key partners in the ID2020 initiative include the Rockefeller Foundation, Microsoft, and the United Nations, all frequent targets of conspiracies.<sup>22</sup>

- **Citizen Disarmament:** Conspiracy theorists believe it is just a matter of time before a full-fledged effort to repeal the Second Amendment is attempted. There are several versions of this conspiracy in “Conspiracy Literature.”<sup>xi</sup> In one version, the United Nations, acting through the UN Charter, orders the United States to completely disarm and turn over its military to the UN.<sup>23</sup> It is unclear if the citizenry will also have to turn in their personal firearms, however, the at least one author maintains the UN Charter was written and passed to serve as the supreme law of the planet.<sup>24</sup> In another version, the US is overthrown during a national crisis, citizens of concern are incarcerated, and the US Constitution is replaced by a new constitution which forbids personal firearm ownership.<sup>25</sup> In other versions, a “leftist” government rescinds the Second Amendment.<sup>26</sup> In online discussions, the United Nations and “leftist” ideology are often cited as the source of what is believed to be an inevitable “gun grab.”<sup>xii</sup> Conspiracy theorists claim the purpose of removing weapons from US citizens is to ensure their compliance under a totalitarian government, likely the NWO.<sup>27</sup>

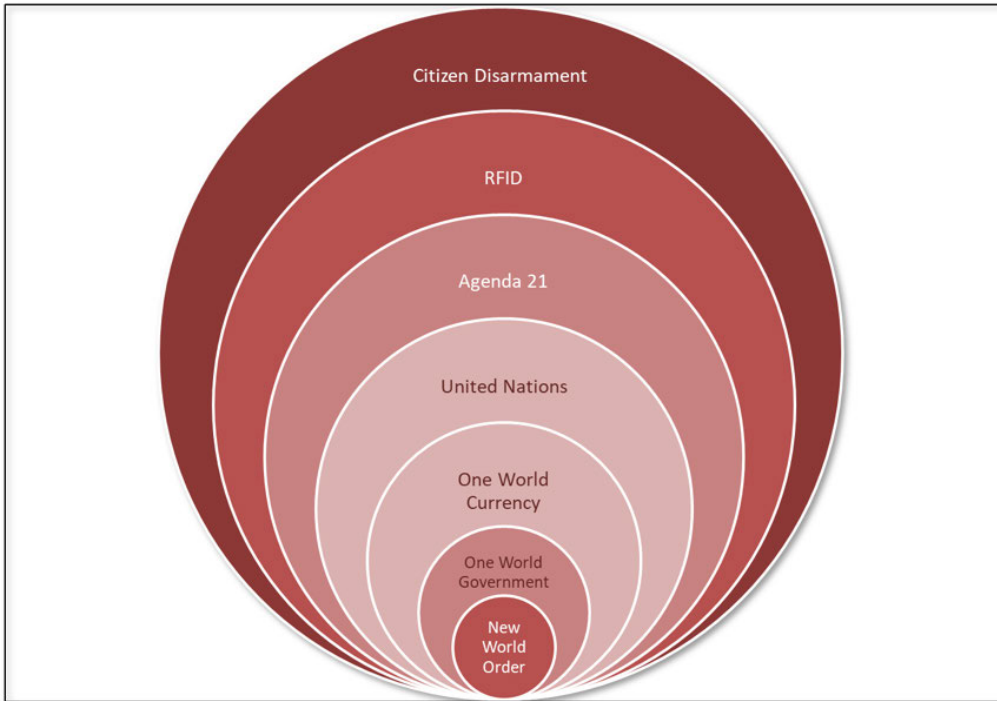


Figure 2: Basic Elements of the New World Order Conspiracy

## The New World Order: Basic Elements - False Flags



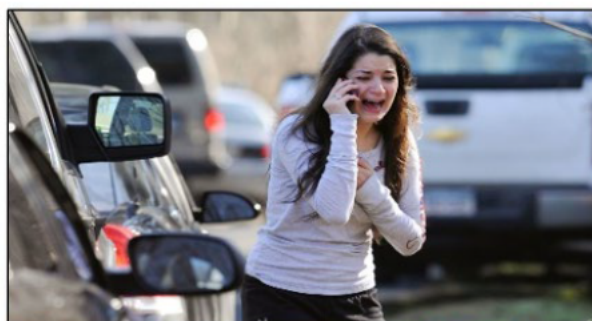
**False Flag:** an attack or other hostile action that obscures the identity of the participants carrying out the action while implicating another group or nation as the perpetrator.

False Flag accusations are a cornerstone in conspiracy narratives. Conspiracies thrive on the rejection of “official” government statements and information provided by the “mainstream news media” (MSM). The belief in False Flags serves as a primary entry point into conspiracy ideology.

The term “False Flag” is used almost exclusively for *events* such as September 11<sup>th</sup>, Sandy Hook (*Figure 3*), and January 6<sup>th</sup>. With the declaration of a False Flag, conspiracists debate on various interpretations of the event until convincing “evidence” is presented and agreed upon. The new narrative becomes conspiracy cannon and is incorporated with other conspiracies if possible.<sup>xiii</sup>

**Crisis Actors** are an essential element to False Flag narratives. Crisis Actors are persons who conspiracists believe are planted at a scene to convince the public the event is real. Persons accused include victims, survivors, and responders.

Conspiracists point to the government’s use of Crisis Actors during disaster exercises as proof these actors exist. Conspiracists go to great lengths prove their theories, often taking photos of similar looking victims at other events and claiming they are the same people.<sup>xiv</sup>



### SANDY HOOK SCHOOL SHOOTING

On December 14, 2012, Adam Lanza<sup>USPER</sup> entered the Sandy Hook Elementary School and killed 20 students. Six adults, including Lanza’s mother, were also killed on that day.

Conspiracists quickly labeled the event a False Flag while accusing victims, survivors, and responders of being crisis actors. Families have been aggressively pursued by conspiracists intent on proving the children are actually alive or never existed.

The term False Flag goes back to the 16<sup>th</sup> century and has ties to naval warfare;<sup>28</sup> however, modern conspiracy use of the term stems from a CIA effort in 1961 named OPERATION NORTHWOODS. The operation was a plan by the United States to establish a pretext for the invasion of Cuba and to remove its communist government.<sup>29</sup>

For conspiracists, OPERATION NORTHWOODS serves as an explanation, at least in part, for the events of September 11<sup>th</sup>, 2001. Conspiracists also refer to this operation to prove a long-standing pattern of deceitful and malicious behavior on the part of the U.S. government.<sup>xv</sup>

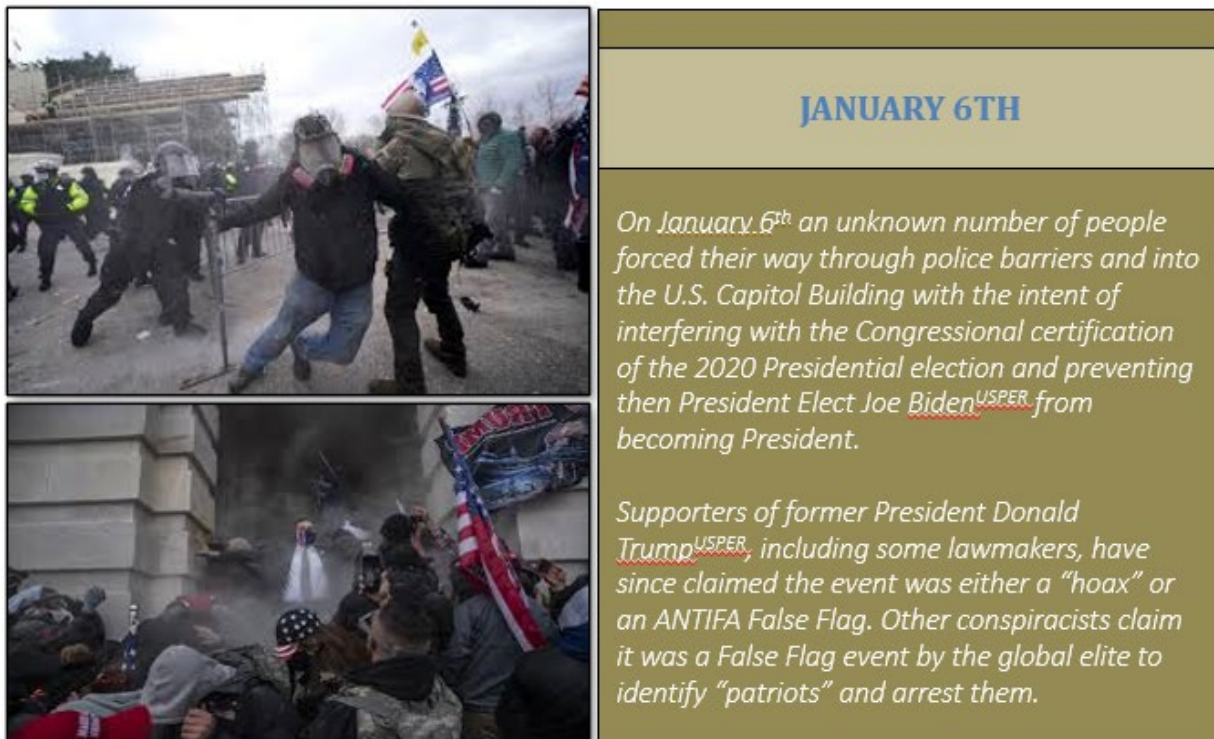


Figure 4: January 6<sup>th</sup>, 2021

The False Flag narrative is also associated with the events of January 6<sup>th</sup>, 2021. Supporters of former President Donald Trump allege the rioters at the U.S. Capitol Building are from the leftist ANTIFA movement posing as Trump supporters (*Figure 4*).<sup>30, xvi</sup>

Conspiracists also believe a global False Flag event will precipitate the One World Government.<sup>xvii</sup>

**Analyst Comment:** *Although not completely a False Flag accusation, OST was implicated in the JADE HELM conspiracy. JADE HELM was a military exercise which occurred across several states during which military forces were deployed in certain American towns to practice specific tactics prior to overseas deployment.<sup>31</sup> The conspiracy narrative regarding JADE HELM stated then President Barack Obama<sup>USPER</sup> would direct the military to take over the United States under the cover of a military exercise. The unusual look of OST’s vehicles led some to believe they were a part of JADE HELM, and by extension, part of the planned military take-over.*

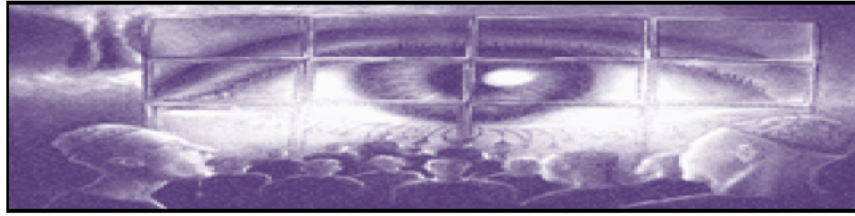
*Although OST agents did not suffer any violence, the volatile nature of the current political climate suggests a distressing conspiracy involving OST’s vehicles may lead to a confrontation with conspiracy-oriented citizens.*

## The New World Order: Basic Elements - Predictive Programming

*“We predict the future. The best way to predict the future is to invent it...”*  
- The Well-Manicured Man, X Files (TV show 1995)

“Predictive Programming” is defined as the NWO’s use of multimedia to prepare the public for future events or introduce the public to societal changes.<sup>32</sup> Predictive Programming is an essential element to the NWO conspiracy narrative. However, as this sub-narrative is both intricate and comprehensive, an entire section will be dedicated to its description.

Conspiracists maintain the global elite use mass media to expose the public to societal changes or future events.<sup>33</sup> Some conspiracists suggest this is to reduce resistance to said events and societal changes.<sup>34</sup> Other conspiracists claim the Illuminati/Global Elite have a code-of-conduct to which they must adhere.<sup>xviii</sup> The code-of-conduct, according to some conspiracists, requires they somehow inform the public of these events without telling them directly.<sup>xix</sup>

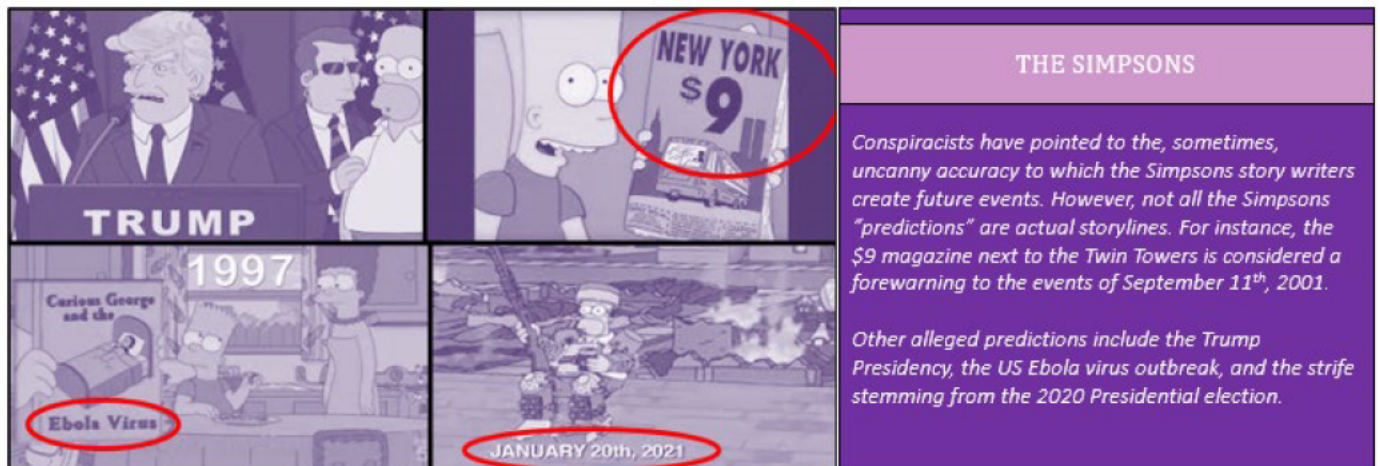


Figure 5: The Simpsons Television Series

Conspiracists point to numerous television shows, documentaries, songs, games, and books as proof predictive programming is real (Figure 5).

Some conspiracists believe the global elite are “playing a game” with the public by deliberately foretelling of their plans as a kind of boast.<sup>xx</sup> Games such as *Illuminati* and *Drowned God* purport to reveal both the alleged plans of the global elite and future events (Figure 6).

Conspiracists claim the global elite also use mass media to communicate their signs, symbols, and ritual activities. For instance, various sun symbols in the background of movies are seen by conspiracists as deliberate implantations of Luciferian icons. Other signs include triangles, which some conspiracists attribute to pedophilia, red shoes, and certain hand gestures.<sup>xxi</sup>



Mass media is not the only way conspiracists believe the global elite are communicating their plans. Conspiracists also claim various monuments and structures are deliberately designed to demonstrate the dominance of the global elite or communicate their plans.



In addition to the Georgia Guidestones, the Denver Airport (Figure 7), the Statue of Liberty, and the Kindlifresser ("Child Eater" shown left) statue in Switzerland are all mentioned in conspiracies linked to the global elite.

The Child Eater is believed by conspiracy theorists to depict the long tradition of child sacrifice among the elites.<sup>xxii</sup>

**Analyst Comment:** Predictive programming does not represent a threat to OST. However, widely distributed mass media involving a fictitious nuclear accident, nuclear escort vehicles, or a theft of a nuclear device could bring attention to OST. RAD continues to monitor the evolution of various conspiracies on the Internet.

# 5

## The New World Order: The Satanic Version

The Satanic version of the NWO conspiracy rests almost exclusively on Christian apocalyptic beliefs stemming from the Book of Revelations.<sup>xxiii</sup> In this narrative, the NWO serves as the government of the Anti-Christ, RFID or the single global currency as the “mark of the beast,” and the UN army as the force the Anti-Christ will use to control the world.<sup>xxiv</sup>

Conspiracists dedicated to the biblical interpretation of the New NWO interpret all elements of the NWO in relation to the Anti-Christ.<sup>xxv</sup>

The following paragraphs describe some elements typically seen in the satanic version of the NWO conspiracy:

**The Global Elite:** On social media, conspiracy theorists frequently accuse the global elite of satanic worship and participation in satanic cults. In the book of Revelation, the Anti-Christ is said to gain dominion over all nations through deceit.<sup>35</sup> Conspiracy theorists view the elite as the minions of the Anti-Christ, assisting in his ascension as ruler over the earth.

**Satanic or Occult Ritual:** Conspiracy theorists frequently accuse the global elite of ritual sacrifice to various deities to include Moloch, Lilith, Baal, and Lucifer.<sup>xxvi</sup> Moloch is the ancient Canaanite god of child sacrifice.<sup>36</sup> Conspiracy theorists frequently accuse the global elite of ritual child sacrifice, particularly under the *QAnon* conspiracy theory.<sup>xxvii</sup> Some conspiracy theorists believe the giant owl at Bohemian Grove (right) located in Monte Rio, California, is a representation of Lilith. Depending on the tradition, Lilith was the non-submissive first wife of Adam, or a Sumerian demon preying on pregnant woman and infants.<sup>37</sup> The owl's mystical significance, in this case, is also believed to be “secret knowledge.”<sup>38</sup> Other alleged rituals of the elite include satanic rituals, which allegedly include human sacrifice.<sup>xxviii</sup>



**Mistrust of the Vatican:** Depending on the source of this narrative, the Vatican is viewed as either attempting to facilitate the NWO in support of the Anti-Christ or is the system through which

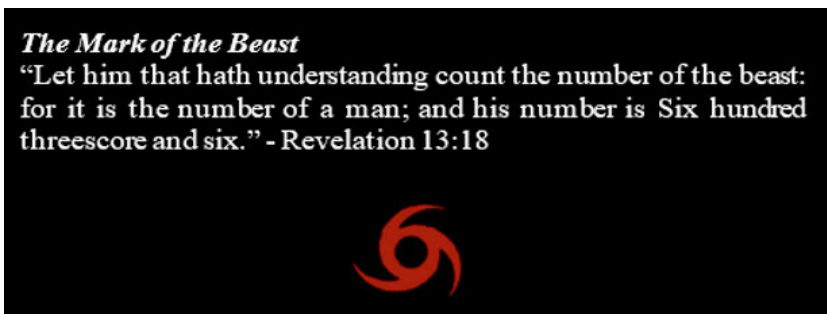


the Anti-Christ will reveal himself.<sup>xxix xxx</sup> Further accusations against the Vatican include conducting “black masses,”<sup>39</sup> ritual sacrifice,<sup>xxx</sup> and withholding vast amounts of secret information in hidden vaults.<sup>xxxii</sup>

**Spiritual Warfare:** Conspiracy theorists who believe there is as a battle between God and Satan often claim the political differences between the two major American political parties is a “battle for America’s soul.”<sup>xxxiii</sup>

**The Mark of the Beast:** The *Mark of the Beast*<sup>40</sup> is a frequent feature in Christian apocalyptic discussions. Conspiracy theorists blend their faith with emerging narratives involving RFID, FEMA camps,<sup>41</sup> and Agenda 21.<sup>xxxiv</sup> In short, conspiracy theorists of the religious persuasion believe all citizens of the world will be required to wear the mark of the beast to conduct any kind

of transaction. Those who refuse will be arrested and sent to FEMA camps for execution.<sup>42</sup>



Many conspiracy theorists believe the NWO is working to erode belief in essential, core principles such as gun ownership, heterosexual

marriage and romantic relationships, national sovereignty, and capitalism.<sup>43</sup> However, Christian conspiracists view these changing values as a deliberate deception to turn the population away from Christ and traditional American values in preparation for the rule of the Anti-Christ.<sup>44 45</sup>

**Rejection of Science:** Many conspiracists who view the world through the satanic interpretation of the NWO may reject scientific information such as Global Warming, health information, vaccines, astronomical explanations of the universe, and anything pertaining to evolution. In recent years, social media has seen a resurgence in “Flat Earthers,” conspiracy theorists who believe the world is flat, spins like a disc, and is contained within a dome, like a snow globe.<sup>xxxv</sup>

**Fallen Angels:** Many conspiracists of the religious persuasion reject the idea of extraterrestrials in favor of fallen angels. The fallen angels are viewed as deceivers of man, working to separate humanity from God in various ways including the belief in extraterrestrial life, scientific discovery, and personal vices.<sup>xxxvi</sup> The deception is believed to be preparing the world for the Anti-Christ.<sup>xxxvii</sup>

**Adrenochrome:** Adrenochrome is a pigment created during the oxidation of adrenaline.<sup>46</sup> In another form, *adrenochrome monosemicarbazone*, the substance serves as a hemostatic in the bloodstream.<sup>47</sup> In conspiracy circles, adrenochrome is a substance the elite believe carries mystical powers. Various conspiracies indicate adrenochrome in its purest and most potent form can only be extracted from a child under torture at the time of death. Adrenochrome is discussed further below.

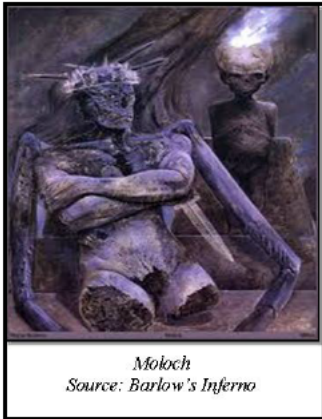

**Child Sacrifice:** Child sacrifice requires special attention as this topic has become a major element in current conspiracy theories. Sexual misconduct allegations against the rich and powerful has a long history. In classical literature from the likes of the *Marquis De Sade*, the economic and political elite, to include clergymen, are described performing satanic rituals and sadistic sexual acts on hapless victims.<sup>48</sup>

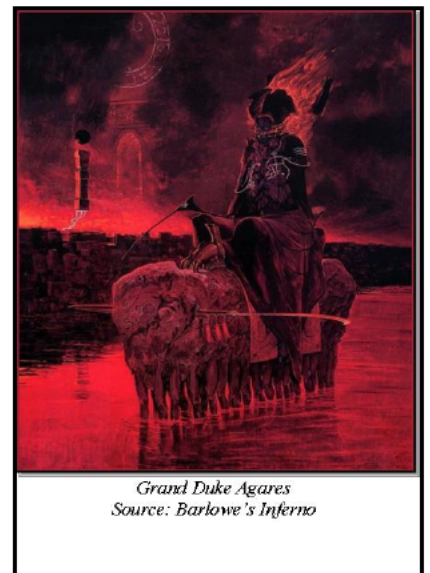

There are several versions of this conspiracy. The primary version of this narrative stems from the QAnon conspiracy which claims the global elite, including current and former world leaders, actors, and other prominent persons, engage in child sex trafficking and satanic child sacrifice.<sup>xxxviii</sup> Other QAnon variants include sacrificing children to the ancient deity Moloch (left), for the purposes of gaining material wealth, power, and longevity.<sup>xxxix</sup> The QAnon conspiracy will be discussed in greater detail in a later chapter.

One final version of this conspiracy extends back several decades to missing children cases in Nebraska and Iowa, and an alleged child sex trafficking case in Franklin, Nebraska in 1988.<sup>xi</sup> In the 1980's two male juveniles were believed abducted while working paper routes in Des Moines, Iowa. Both cases are believed by private researchers and conspiracy theorist Ted Gunderson<sup>USPER 49</sup>, to be connected to a child sex trafficking ring operating throughout the United States and Mexico.<sup>50</sup> The alleged child sex trafficking ring was said to have serviced politicians all over the United States, to include Washington, D.C.<sup>51</sup>, engaged in child torture and satanic ritual sacrifice, and auctioned children to wealthy global elites and organ harvesters.<sup>52</sup> Gunderson claimed the alleged orchestrator of this criminal organization is the CIA.<sup>xii</sup>

Current child sex trafficking conspiracy theories may include stories concerning the role of torture during ritual sacrifices. Some conspiracists claim torturing a victim prior to death provides a type of energy perpetrators "feed" upon.<sup>xliii</sup> <sup>53</sup> In one version, the perpetrators torture the victim to near death, seeking maximum pain, and then harvest adrenochrome from the victim and drink it to gain magical power, consume the victim's life force to elongate their own, or experience a unique hallucinogenic high.<sup>54</sup> <sup>55</sup> In another version, the victim's blood is extracted at the point of maximum pain and consumed for the same purposes listed above.<sup>xliii</sup> Cannibalism may or may not be involved, depending on the narrative. Victim torture of this type may originate in UFO lore which includes stories involving reptilian extraterrestrials abducting, torturing, and drinking the blood of victims, eating victims (particularly children), to consume their life force (reptilians discussed in later sections).<sup>56</sup> In all versions, children are preferred victims as their life force, and their experience during torture are considered the purest and most potent.<sup>57</sup>

## The New World Order: The Extraterrestrial Version

*“The creatures here are primitive – but we do not harm them, for they are like children to us. We teach them all our secrets...”*

- Drowned God: Conspiracy of the Ages

A less prominent but noteworthy version of the NWO conspiracy is the belief extraterrestrials are either posing as, or maintain control of, the global elite.

As with all conspiracies, this narrative of the NWO has several versions. In one version, humanity’s understanding of God, heaven, and angels are the result of extraterrestrial contact.<sup>xliv</sup> <sup>58</sup> Another version states extraterrestrials are responsible for the creation of humanity through evolutionary intervention.<sup>xlv</sup> Yet another version states the first detonation of a nuclear weapon prompted extraterrestrials to establish contact with US Presidents Truman and Eisenhower.<sup>59</sup> <sup>60</sup>

The extraterrestrial version of the NWO includes alien abductions, shapeshifting reptilians, and imposed space exploration restrictions on humanity. Across the differing extraterrestrial narratives lies consistent elements to each version, discussed below:

**Origin Story:** There are several variations to the story of initial contact between extraterrestrials and humans. In one version, the extraterrestrials came into our universe from another realm.<sup>61</sup> In this version, the extraterrestrials (or extra-dimensional beings)<sup>xlvi</sup> act as gods to humanity and are credited for the ancient myths of gods interacting with humans and for biblical events such as Moses’ reception of the Ten Commandments.<sup>62</sup> They are also accused of playing with the fates of men and the for stories of cross breeding between angels and humans.<sup>63</sup> Extraterrestrials are also credited with the advancement of early human knowledge which led to civilization.<sup>64</sup>

Some conspiracy theorists point to ancient religious texts and myths as proof of extraterrestrial contact with humanity. Stories of “gods” battling in the sky in the Vedras, a similar story of a war in heaven in the Bible, and myths of wars between Egyptian gods are used as evidence of the ancient

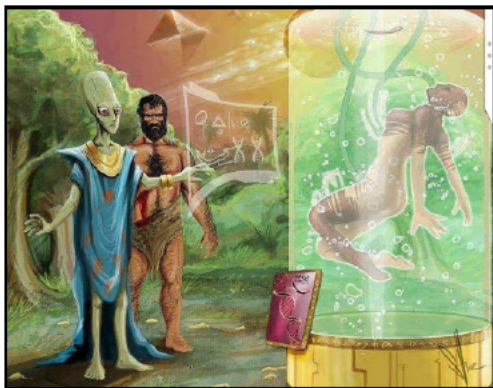

extraterrestrial presence on Earth and contact with humanity.<sup>65</sup> Carried through history, some conspiracy theorists believe extraterrestrials have maintained control over humanity, guiding events as human civilization advances.<sup>66</sup>

Ancient Sumerian gods and reptilian extraterrestrials play a prominent role in some UFO conspiracy narratives. Some *Ancient Astronaut* theorists<sup>xlvii</sup> claim a mythical race of Sumerian deities known as the Anunnaki are extraterrestrials.<sup>67</sup> Other conspiracy theorists claim the Anunnaki are involved in human affairs and have been since antiquity.<sup>68</sup>



The same myths are used to argue that these extraterrestrials are responsible for human evolution.<sup>69</sup> In this version, conspiracy theorists believe humanity's natural evolution was "interrupted," resulting in *Homo sapiens*. This narrative may include the mixing of reptilian DNA with human DNA, allegations of interbreeding, and the claims that humanity was created to be a slave race.<sup>70</sup>

A modern version of the extraterrestrial narrative alleges aliens established contact with former US Presidents Truman and Eisenhower.<sup>71</sup> According to some versions of this story, humanity's entry into the nuclear age prompted extraterrestrials to contact the nation which possessed this power.<sup>72</sup> There are several competing variants of this sub-narrative. One states that, depending on the species, aliens are here to help humanity ascend to a higher civilization, while another variation claims aliens are here to "help humanity ascend to a higher existence." The most current narrative warns the alien's intent is unknown, is not to be trusted, and "is likely not in the best interest of humanity."<sup>xlviii</sup>

**Abduction:** Alleged alien abduction of humans and other Earth life forms is a consistent element to extraterrestrial conspiracies, including those involving the NWO. One of the earliest and more familiar alien abduction stories occurred in 1961 when two US citizens claimed they were abducted in New Hampshire while driving home from Niagara Falls.<sup>73</sup> The two victims claimed the abduction occurred in a rural area, during which they were put into a kind of trance. They further claimed they were taken aboard an aerial vehicle of some kind, questioned by its non-human occupants, and subjected to physical examinations.<sup>74</sup>

Alien abduction stories, also referred to as "close encounters of the fourth kind,"<sup>xlix</sup> occur in several forms. One type involves humans who are removed from their bed during sleep. In these stories, a person is removed from their home while asleep, taken aboard a craft and subjected to examinations and then returned home. In another version, a person is in an isolated area while driving or camping, etc., and abducted. In yet another version, the person willingly goes with the aliens, participates in the examinations or experiments and returns home. According to the various stories involving involuntary abduction, the victim usually does not immediately remember the experience, but may find strange scars, rashes, and injuries on their person, and may experience flashbacks.<sup>75</sup> Abduction stories may also include underground facilities. Underground facilities will be discussed in greater detail below.

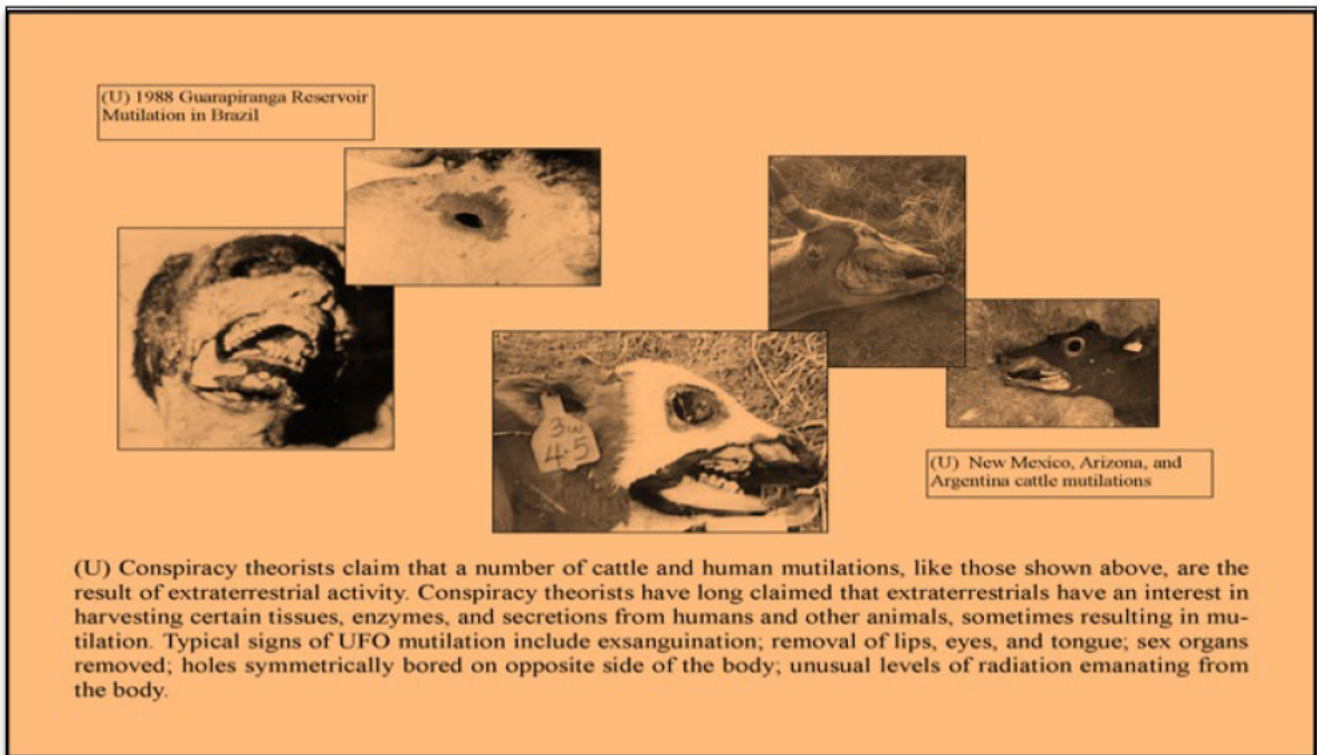


Figure 8: Mutilations

Some UFO researchers claim the pattern of alien abductions suggests humanity is under threat. The current narratives regarding alien abduction include more troubling elements such as forced breeding with alien-human hybrids, DNA extraction, live vivisection, removal and reattachment of limbs, involuntary insemination, removal of pregnancy, harvesting of sperm and ova, and the implantation of behavioral instructions.<sup>i</sup> Some UFO researchers claim the information above indicates an alien-human hybridization program of some sort is occurring, and the abductions are a major component of the program.<sup>ii</sup> Conspiracists also claim some abductees are killed during the experience. In stories involving "strange disappearances," persons who seemingly "disappear out of thin air" allegedly reappear deceased days later in an unexpected location already cleared by search teams. These victims may not show any signs as to the cause of death.<sup>76</sup> According to conspiracists, some abductees claim to have seen numerous human corpses in underground military facilities occupied and controlled, at least in part, by extraterrestrials.<sup>iii</sup> Extraterrestrials are also blamed for numerous cattle and human mutilations all over the world (Figure 8).

A final component of the abduction narrative states military and national security personnel conduct a second abduction of victims for debriefing.<sup>iiii</sup> Conspiracy theorists claim the government is working hard to identify the scope, nature, purpose, and goals of the alien presence. Conspiracy theorists and researchers also claim the aliens are neither forthcoming nor truthful with governments as to their intentions toward humanity. According to this sub-narrative, the Eisenhower administration granted the extraterrestrials permission to establish bases of operation and abduct a small amount of citizens, provided none would be harmed, and all would be returned home.<sup>77</sup> Conspiracy theorists

claim aliens quickly broke their agreements with the US and have been conducting operations as they see fit ever since.<sup>78</sup>



**Men in Black (MIBs):** UFO conspiracy theorists, UFO researchers, and alien abductees have reported “men in black” in areas of UFO activity. MIBs are government agents or alien hybrids which threaten, seek to confuse, or kill anyone who may expose the “alien conspiracy.”<sup>liv</sup> According to conspiracy theorists, former Director of Central Intelligence James Forrestal, and Presidents Eisenhower and Kennedy are allegedly among those “silenced” before they disclosed extraterrestrial information to the public.<sup>79</sup>

**Cover-up:** Conspiracy theorists and some UFO researchers claim extraterrestrial interaction with the United States government has been “covered up” for more than 70 years. The most agreed upon starting point is the Roswell UFO incident of 1947 in which the US Army stated they recovered a “flying disk,” only to correct this statement to a weather balloon. Years later, the weather balloon claim would again be corrected to “Project Mogul,” which involved a high-altitude balloon with sensitive military equipment (*Figure 9*). Conspiracy theorists reject the explanation.

(U) In early July, 1947 a New Mexico rancher reported metallic debris on his land. On July 8th, 1947 the US Army Air Force issued a press release stating:

*“The many rumors regarding flying discs became a reality yesterday when the intelligence group of the 509th (atomic) Bomb Group of the 8th Air Force, Roswell Army Air Field, was fortunate enough to gain possession of a disc through the cooperation of one of the local ranchers and the sheriffs office of Chaves County.”*

Conspiracy theorists claim both Presidents Truman and Eisenhower were briefed on the alien presence, beginning with Roswell, and Eisenhower eventually met and established a treaty with extraterrestrials known as “the Greys.”<sup>80</sup> <sup>lv</sup> Conspiracy theorists also claim 11 alien civilizations eventually established contact with the United States, with some issuing warnings about the Greys. Other versions of this story claim the United States entered the treaty to gain technology and access to the aliens for study. Conspiracy theorists also claim an exchange program between the Greys and the US occurred, in which one alien stayed with the United States military and twelve humans went to the alien’s home world.<sup>lvi</sup>

The alleged cover-up also includes underground military bases, where aliens live and work, and where recovered alien technology is stored and studied for reverse engineering. A major narrative includes an alleged underground base in Dulce, New Mexico where a supposed battle occurred between alien greys and US soldiers.<sup>81</sup> Other allegations include the infamous Area 51, where noted former Area 51 employee Bob Lazar<sup>USPER</sup> claims captured extraterrestrial aircraft are kept and studied.<sup>82</sup>

**Reptilians:** Also referred to as “Reptalins.”<sup>83</sup> Numerous UFO conspiracies allege reptilian-looking extraterrestrials are here on earth. The conspiracies vary in the role of these extraterrestrials. One conspiracy theory states the reptilians arrived from Alpha Draconis, imparted knowledge in math, science, astronomy, agriculture, and horticulture.<sup>lvii</sup> This version claims the reptilians maintain control of the NWO and do so by shapeshifting to look like humans.<sup>84</sup> Another version claims the reptilians are visiting earth, but do not represent a significant presence on earth as compared to other races.<sup>85</sup> Conspiracy theorists may also claim reptilians are evil, may hate humanity, have control of underground military bases, and engage in human (child) sacrifice for adrenochrome.<sup>86</sup>



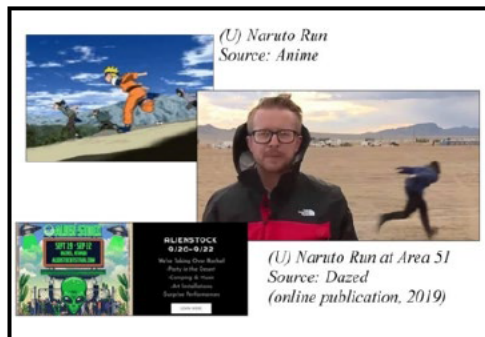

**Global Control:** There are also several narratives regarding humanity’s position with the aliens. In one version, the aliens are directing the global elite to establish a single world government. In other stories, alien hybrids or shapeshifters (reptilians) pose as human leaders. In all versions, humanity is viewed as a lesser species to which the aliens can do what they will.<sup>lviii</sup> <sup>87</sup> Abductees allege when they ask or demand to be left alone, the aliens say “humanity belongs to them.”<sup>88</sup> Some researchers claim humanity has been “quarantined” to Earth and will remain so for as long as humanity remains in its current global political condition.<sup>lix</sup>

**Analyst Comment:** UFO conspiracies present security challenges to the Department of Energy and operational challenges to OST. In 2019 several thousand people arrived in Rachel, Nevada for “Alienfest/Alienstock.” The event, which started as a hoax on Facebook<sup>USBUS</sup> “went viral,” and evolved into an actual event to which 1.5 million people claimed intent to attend. The primary feature of this event was to be the “storming of the gate,” in which the attendees would “naruto run” past security, all the way to the secure buildings to find proof aliens exist, and the rumors of stored alien craft at the sites are true. OST sent agents to assist with security at NNSS during the event.

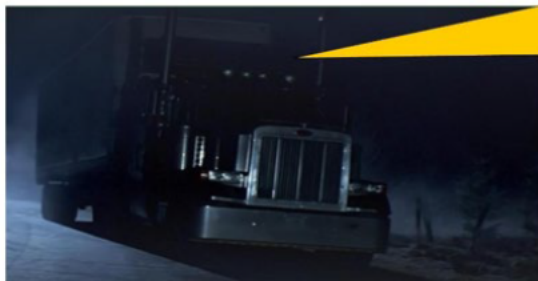

OST vehicles have been mixed up in UFO “Men in Black” conspiracies. In 2008, a news media outlet in Las Vegas, Nevada stated OST vehicles were seen by residents near the location of an alleged UFO crash. The news story suggested citizens believed government vehicles of a strange and unknown type may have been involved in the investigation and transport of UFOs from the incident. The news outlet eventually identified and cleared OST of involvement with the incident.

The persistence of UFO conspiracies is fueled by approximately 70 years of declassified government documents on the subject. Numerous government agencies and bodies including the military, Congress, and the CIA have released or declassified documents relating to the “UFO phenomenon.” Some UFO researchers point to the existence of these documents as proof of the extraterrestrial presence on earth and the reality of alien abductions.



## The New World Order: The Corporate Version

*“Permit me to issue and control the money of a nation, and I care not who makes its laws...”*  
*Mayer Anselm Rothschild, 1790*

The corporate version of the NWO conspiracy states mega corporations will fulfil the goals of the NWO for the purposes of enslaving humanity through hyper consumerism and perpetual debt. The corporations will either control governments or act as governments and serve the global elite.

The corporate version of the NWO is absent metaphysical elements in its descriptions, focusing strictly on political and economic power. Although this version of the conspiracy is absent the supernatural, it does possess elements specific to the narrative:

### Themes

**Corporatocracy:** The type of government conspiracists believe the world is either moving toward or is currently under. According to texts such as *Confessions of an Economic Hitman*, a corporately controlled system seeks to control global financial assets and critical infrastructure through predatory practices.<sup>89</sup> The features of a corporatocracy, according to conspiracy theorists, include the ruling elite, a rigged election system, corporate control of all government features, predatory lending, debtor’s prisons, an economic class system, and brutal police forces.<sup>lx</sup>



**Individuals as Corporate Assets:** Conspiracists claim US citizens are sold into corporate slavery at birth, with the assigned Social Security Number serving as the “straw-man” corporation or trust account identification. The accounts are set up to offer the citizen as collateral “by selling their future earning capabilities to foreign investors.”<sup>90</sup>

**International Banksters:** *International Banksters*, *International Banking Cartel*, or *Banksters*, are terms used by conspiracy theorists to describe the leaders of the global banking system.<sup>lxi</sup> Conspiracy theorists claim the creation of central banks, like the Federal Reserve, destroy a nation’s future, its sovereignty, and relegate its citizenry to a life of slavery.<sup>91</sup> Conspiracy theorists claim the leaders of these banks work in unison to rule the world.<sup>92</sup>

**Bilderbergers:** A name given to those who belong to the Bilderberg Group; an informal forum for high level political and cultural discussion between North America and Europe.<sup>93</sup> The

*Bilderberg Meeting* occurs once a year.<sup>94</sup> Conspiracy theorists claim the Bilderberg meetings are held by the global elite to plan and execute global events such as regime changes, assassinations, and financial crises for the purpose of creating a one world government.<sup>lxi</sup> <sup>95</sup>

**Trilateral Commission:** An international “non-governmental, policy oriented” forum through which global leaders can discuss potential solutions to “geopolitical, economic and social challenges.” As with the Bilderberg Group, conspiracy theorists claim the Commission is a forum for the global elite to create a one world government.<sup>lxiii</sup> <sup>96</sup>

**Cashless Society:** Conspiracists claim the Federal Reserve Bank will eventually eliminate physical money from circulation for the purposes of controlling all commerce. Conspiracists also claim no one will be able to participate in the economy or gain access to their finances without an implanted RFID chip.<sup>lxiv</sup>



**Dead Bankers:** Over the last 10 years, conspiracists have focused on the number of suicides and deaths of bankers and financiers. Multiple news media sites have discussed “clusters” of banker suicides, some stemming from the 2007 economic crash.<sup>lxv</sup> Conspiracists have claimed the suicides are actually assassinations, either covering up criminal activity for the global elite or silencing these bankers for their knowledge of an “upcoming event.”

**Analyst Comment:** *Although Sovereign Citizen conspiracies are intertwined with corporatocracy conspiracies, which are briefly discussed here, the information does not represent the beliefs of Sovereign Citizens in totality. Sovereign Citizens will be discussed in a compendium to this document.*

## The New World Order: The Zionist, Freemason, and Illuminati Versions

---



**ZOG:** The Zionist version of the NWO stems mostly from white supremacist literature which claims the Jews have taken over the United States government through the banking industry.<sup>97</sup> Since its beginnings, it has evolved to incorporate the narrative of the NWO. White supremacists refer to this global control as the “Zionist Occupied Government”<sup>98</sup> <sup>lxvi</sup> or ZOG.

White supremacist organizations espouse Jews are trying to kill the white race. White supremacists claim the procreation of non-whites, interracial marriage, abortion, and non-white immigration are methods used by Jews to eliminate whites.<sup>99</sup> White supremacists also claim Jews control Hollywood and the news

media to create narratives favorable to Jews.<sup>100</sup>

The idea of “white-genocide” has foundations in an 1864 pamphlet, meant to trap then President Lincoln in a political scandal involving a new word, “miscegenation.”<sup>101</sup> According to the *Merriam-Webster* dictionary, miscegenation is the blending of a white person with a member of another race.<sup>102</sup> In the years since the creation of the term, some white supremacists use the idea of anti-white eugenics to spread fear and recruit supporters.<sup>103</sup>

Some white supremacist groups use controversial religious texts to justify their hatred of Jews. In the *Christian Identity* movement, Jews are considered the children of Cain, who, in the gnostic tradition, are the offspring of Lucifer and Eve.<sup>104</sup> The “Serpent Seed” myth of Eve and Lucifer conceiving Cain is also supported by some Christian evangelicals when discussing the alleged child sacrifices of the elite. The link between the Serpent Seed myth and the child sacrifices of the elite are also expressed in the QAnon conspiracy.<sup>lxvii</sup>

**Freemasons:** The first Masonic Grand Lodge was established in England in 1717 and has ancestral ties to stonemason guilds of the Middle Ages. Freemasonry incorporates “the rites and trappings of ancient religious orders and of chivalric brotherhoods,”<sup>105</sup> which directly contribute to the allegations of occult or satanic practices within the lodges.<sup>lxviii</sup> Some Masonic conspiracies link the Freemasons and Illuminati, and further claim Freemasons are the direct descendants of the Knight Templar.<sup>106</sup>

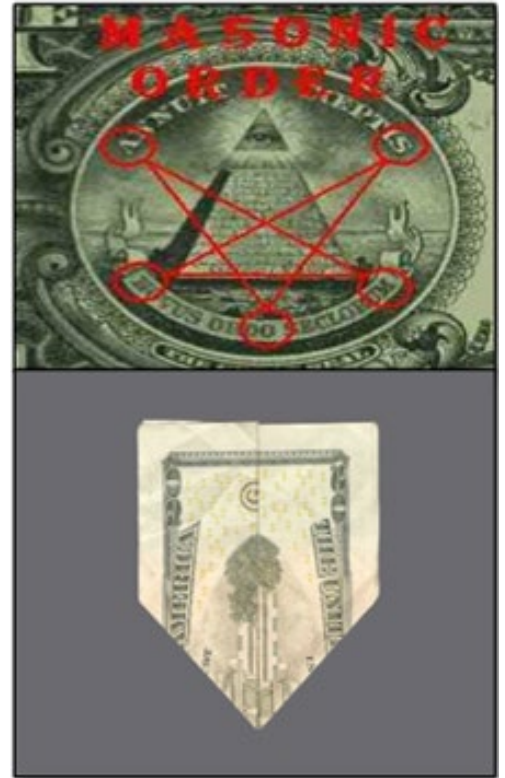
Conspiracists point to Masonic symbolism as proof the Freemasons intend to take over the world. Most recently, the Masonic imagery and phraseology on American currency has been interpreted to show the intent of the Freemasons. Conspiracy narratives include:<sup>lxi</sup>

- An owl as a symbol of the Bilderberg Group and global elite
- Hidden Pentagrams (*Figure 10*)
- Burning Twin Towers when a 20-dollar bill is folded a certain way (*Figure 10*)
- **Ordo Ab Chao:** “Order from Chaos”- usually interpreted by conspiracists to mean “first destroy, then recreate.”
- **Novus Ordo Seclorum:** “New Order of the Ages” – interpreted by conspiracists to read “New World Order.”

**Illuminati:** The term “Illuminati” usually refers to the Bavarian Illuminati founded on May 1st, 1776 and had the stated goal of replacing Christianity with a “religion of reason.”<sup>107</sup> The Illuminati movements<sup>lxx</sup> were an outgrowth of the Enlightenment Period of the 17<sup>th</sup> and 18<sup>th</sup> centuries.<sup>108</sup>

Conspiracists claim the Illuminati are the “elite” ruling class of the NWO.<sup>109 110</sup> There are a multitude of conspiracy books, websites, and social media videos which discuss the Illuminati’s alleged role in the NWO Conspiracy. Some conspiracy narratives overlap the Freemasons with the Illuminati;<sup>111</sup> a narrative which most likely stems from the Bavarian Illuminati’s entry into Masonic Lodges to recruit targeted individuals and grow influence.<sup>112</sup>

As with the Freemasons, the Illuminati were accused of satanic worship; an allegation which continues into modern NWO conspiracies.<sup>113</sup>

## The New World Order: QAnon Conspiracy

---



QAnon is a right-wing conspiracy theory that states Donald Trump<sup>USPER</sup> is engaged in a fight against evil to save America. The “evil” battling Trump is said to be a “cabal” of Democrats, certain members of the intelligence community, certain member of law enforcement, and any other person or organization to which Trump stands in opposition.<sup>114</sup>

The QAnon conspiracy alleges the cabal is involved in child trafficking through which children are subject to ritual sexual abuse and satanic child sacrifice (see previous sections).<sup>115</sup> The QAnon conspiracy further alleges the cabal is communistic in nature, seeks the destruction of the United States, and was trying to thwart the Trump Administration’s agenda.<sup>116</sup>

The conspiracy narrative concludes by alleging US Marines will arrest the cabal, key Democrats, and all enemies of Trump to “restore” America to its “former” greatness.<sup>117</sup> According to the conspiracy, those arrested will be subject to a military tribunal and either imprisoned for life or executed.<sup>lxxi</sup>

QAnon blends numerous conspiracy theories and conspiracy narratives to create its ideology. Most notably, QAnon blends Christian apocalyptic narratives with anti-Communist, “Deep State,” and NWO conspiracies, along with the “Blood Libel,” as the basis for its chronicles.

QUESTIONS POSED IN QANON POSTS THAT BECKON THE READER TO RESEARCH ARE REFERRED TO AS “**BREADCRUMBS.**” THE BREADCRUMBS LEAD THE RESEARCHER “**DOWN THE RABBIT HOLE**” TO QANON POST INTERPRETERS REFERRED TO AS “**BAKERS.**” THE BAKERS INFORM THE QANON FOLLOWERS WHAT THE POST MEANS; AND THROUGH INFORMAL CONSENSUS, A NARRATIVE IS ESTABLISHED.

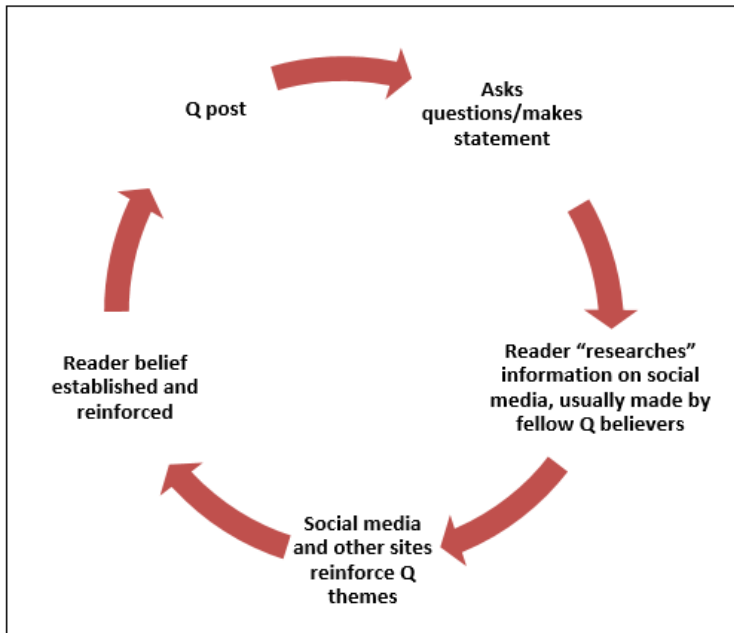


Figure 11: The Cycle of Qanon Posts

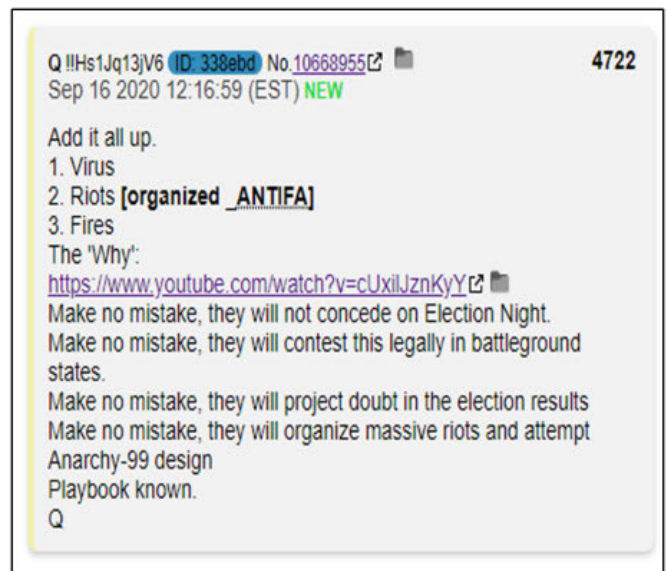
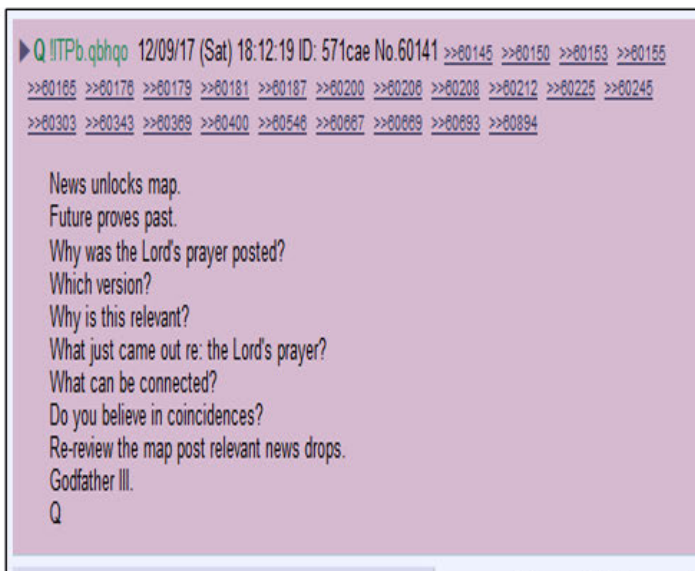


Figure 12: Examples of Qanon Posts

The QAnon conspiracy theory is self-proving; leaving little room for believers of the conspiracy to consider other information (*Figure 11*). QAnon posts make declarations or ask leading questions, then direct followers to websites and/or videos which prove any claims and further support the QAnon narrative. The videos identified through QAnon posts are usually created by QAnon followers, or persons from which QAnon conspiracy theories originate, and serve as proof to followers the conspiracy is real (*Figure 12*).

The QAnon movement has undergone some changes since the 2020 election, which “Q” repeatedly stated was going to be won by Donald Trump. Many QAnon supporters do not accept the results of the election and have created numerous explanations for their beliefs. Others do accept the results of the election and have left the QAnon movement.

Among those who accept the election results, some QAnon supporters have left the conspiracy movement and returned to the non-conspiracy world. Others have remained supporters of the former President, while others have created conspiracy theories against Donald Trump or the Republican Party.<sup>lxxii</sup>

For QAnon followers who do not accept the election results as real, some have remained in the movement, firmly loyal to Donald and await his prophesized return. Others who remain with QAnon have rejected Donald Trump, believe the “Deep State” won, and vow to continue the fight.<sup>lxxiii</sup>

For some QAnon followers, the QAnon movement was a counterintelligence operation based on the Soviet “OPERATION TRUST” of the Bolshevik era. OPERATION TRUST was designed by the communists to lure anti-communists into a front organization for the purposes of identifying and arresting enemies of the Bolshevik Revolution.<sup>118</sup>

Another conspiracy emerged among remaining QAnon supporters stating Donald Trump did not actually lose the election and would return for inauguration on March 4<sup>th</sup>, 2021. When that date did not reveal Trump’s return, new dates were proposed.

The March 4<sup>th</sup> Conspiracy is based on the Sovereign Citizen narrative that America became a corporation under the District of Columbia Organic Act of 1871. The law uses standard language for

the founding of municipalities which includes the term “incorporated,” which Sovereign Citizens and other conspiracists interpret to mean the United States abandoned its status as a Republic and became a corporation beholden to London bankers.<sup>lxxiv</sup>

QAnon advocates violence. At the center of the QAnon conspiracy theory is the belief, *and the desire*, the military will arrest, try, and execute “the cabal” at Guantanamo Bay, Cuba.<sup>lxxvi</sup> In online forums, posts from multiple users calling for independent action, including efforts to violently overthrow the government, are common.<sup>lxxvii</sup>

## On the Horizon: Emerging Conspiracies

RAD is monitoring several conspiracies gaining or may gain prominence in the coming years due to changing social, political, and environmental elements:

**The Great Reset:** A reference to the coming of a one-world financial system that will replace all national currencies.<sup>lxxviii</sup> <sup>120</sup> The Great Reset gained prominence with the emergence of the 2019 pandemic. Conspiracists view the pandemic as a False Flag operation, claiming the global elite intend to use the event (or false event) to complete several goals, including The Great Reset.<sup>lxxviii</sup> This conspiracy is a primary focal point among QAnon supporters as the World Economic Forum discusses a financial reset in response to the global pandemic and Global Warming.<sup>121</sup>

**Anti-science conspiracies:** Scientific advancements, particularly those that contradict the Bible, are targeted by re-emerging and/or new conspiracies. The Flat Earth Conspiracy, the Evolution Controversy Conspiracy, Large Hadron Collider Conspiracy (*Figure 13*), and the Fake Moon Landing Conspiracy have established a foothold on various social media platforms. The primary conspiracy arguments to support these conspiracies are based on historical controversies, self-produced evidence, and the Bible.<sup>lxxix</sup>



**THE LARGE HADRON COLLIDER**

*The large Hadron Collider has been the target of conspiracists since its inception.*

*An artistic video produced for CERN to demonstrate the “cosmic dance” of creation and destruction is viewed by some conspiracists as Satanic.*

*This conspiracy was exacerbated when several CERN scientists created a prank video depicting a human sacrifice by persons wearing black robes. The “sacrifice” occurred in front of the statue of Shiva, located on the CERN campus (left).*

*Conspiracist allegations against CERN include trying to destroy the Earth with black holes and trying to create a portal to release Satan from hell.*

**Agenda 21:** Global Warming is predicted to influence emerging diseases and resulting pandemics.<sup>lxxx</sup> Conspiracists view Global Warming as a False Flag event intended to be used as “cover” for various depopulation methods, including disease and natural disasters.<sup>lxxx</sup>

**5G:** The 5G conspiracy refers to Fifth Generation cellular technology. Conspiracists make an array of allegations against 5G including mind control, RFID chip monitoring, deliberately weakening the immune system for disease propagation, and enhancing the capabilities of the “police state.”<sup>lxxx</sup> 5G conspiracies gained prominence during the pandemic and still play a role the RFID chip allegation against vaccines.<sup>lxxxii</sup>

**QAnon:** The QAnon movement is undergoing changes, catalyzed by the election of President Biden<sup>USPER</sup>. At present, the movement still maintains the 2020 Presidential Election was a fraud, the military is in charge under Michael Flynn<sup>USPER</sup>, and Donald Trump will return. QAnon’s advocacy for violence, mixed with religious moralism, suggests it will remain a source of potential violence for the foreseeable future.<sup>lxxxiii</sup>

**Area 51:** A new report disclosing information on Unidentified Aerial Phenomena (more commonly referred to as UFOs) will be released sometime in June of this year.<sup>123</sup> The report will pull from information obtained from the Office of Naval Intelligence, the Unidentified Aerial Phenomenon Task Force, and the FBI.<sup>124</sup> The report follows a series of highly publicized information releases by the US Department of Defense involving interactions between unusual unidentified aircraft and US naval aircraft, and the Defense Department’s admission of a special program focused on investigating these events.<sup>125</sup> RAD believes that some conspiracists currently engaged in other conspiracy efforts will redirect their attention to UFOs and Area 51.



**Sabmyk:** This conspiracy emerged in the QAnon forums in December of 2020. The conspiracy alleges the Messiah will emerge according to the “Noah Prophecy.” The creators of this conspiracy tell readers to look for the “signs” on the Messiah, including distinctive marks on the palm of the hands. The conspiracy is accompanied by another sub-conspiracy referred to as “The Sword of Shawunawaz” (Light of Orion) which claims the sword carried by Alexander the Great, Gilgamesh, and Achilles, will also be carried by the Messiah.<sup>lxxxiv</sup>

**Analyst Comment:** *These conspiracies do not present a known threat to OST and are presented for situational awareness. The possibility remains a new conspiracy encompassing one of these narratives will emerge and involve OST vehicles and personnel. RAD believes such targeting will be the likely result of misidentification and will be quickly resolved.*

## In the Crosshairs: DOE Customer Facilities, NNSA, and OST

***“May you live in interesting times.”***

*Ancient Chinese Curse (Apocryphal)*

**The Minot Mystery:** On August 31<sup>st</sup>, 2007, a B52 transported unauthorized nuclear weapons from Minot AFB, North Dakota, to Barksdale AFB, Louisiana. In the months that followed, conspiracies began to emerge about a “cover-up” by the Air Force and the Bush Administration.<sup>126</sup> <sup>lxxxv</sup>



At the center of the conspiracy narrative was an alleged “cluster” of Air Force deaths that conspiracists believed were targeted assassinations. The conspiracists suggested the deaths are an effort to cover-up the potential theft or unauthorized transfer of nuclear weapons outside of the United States for a False Flag attack on a foreign adversary.<sup>lxxxvi</sup>

**Analyst Comment:** *Although this conspiracy does not implicate OST, a new conspiracy narrative focusing on a DOE customer facility involving the unauthorized transfer of nuclear weapons could easily incorporate OST.*

*The Minot conspiracy narrative emerged when social media was still in its infancy. Federal agencies face a far more robust and, undoubtedly, significantly more hostile response in the present social media environment. As RAD previously reported in its Information Operations assessment, social media narratives are established quickly, often within minutes of a major event. Once established, social media narratives remain difficult to effectively counter.<sup>127</sup>*

**JADE HELM:** JADE HELM was a military exercise focusing on special operations in preparation for foreign battlefields. The exercise took place on public and private lands across multiple states.<sup>128</sup> Conspiracists viewed the exercise as an attempt by the Obama Administration to conduct a military-takeover of the United States.<sup>lxxxvii</sup>

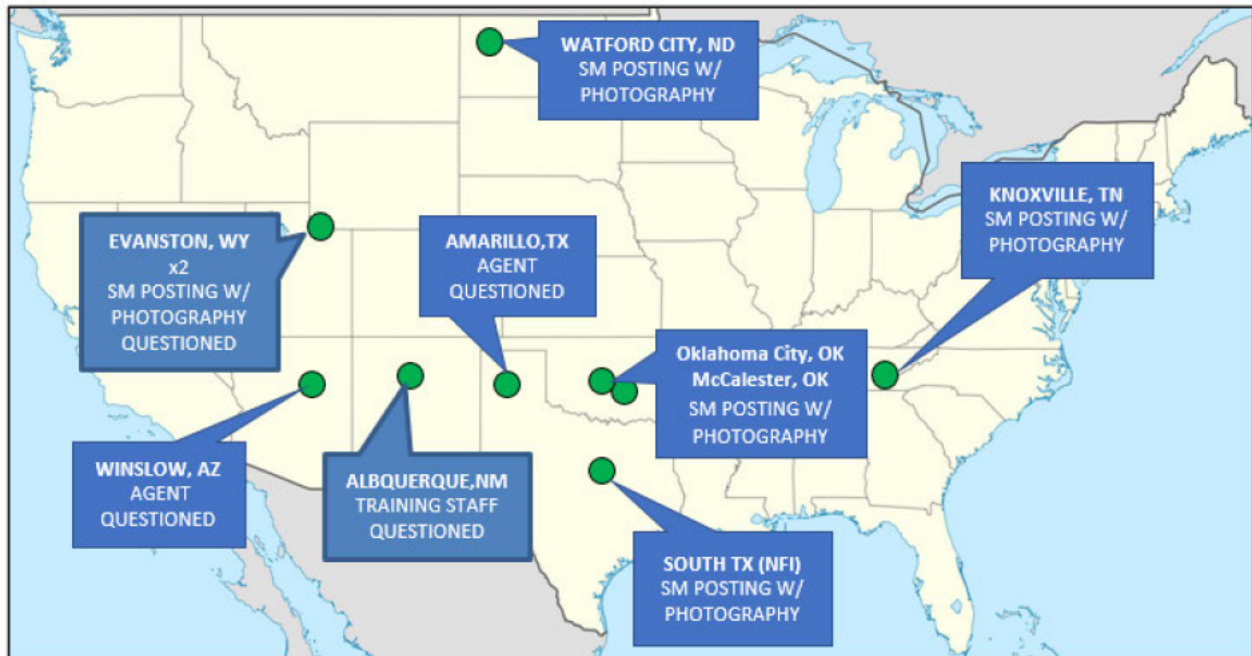


Figure 14: Social Media Postings and OST FA Public Interactions Related to JADE HELM

Conspiracists created numerous forums on social media to specifically discuss JADE HELM and share updates. Much of the “evidence” presented included photos and videos of military convoys, military rail shipments, Wal-Marts<sup>lxxxviii</sup> closed for remodeling, and statements from the Obama Administration. OST vehicles were incorrectly identified as part of the exercise (*Figure 14*).<sup>129</sup>

**Analyst Comment:** OST escort vehicles were photographed on multiple occasions during the JADE HELM exercise. Posts online made various claims about OST’s vehicles, including allegations they were unmarked United Nations vehicles.<sup>lxxxix</sup> The United Nations is a central character in the NWO Conspiracy. Given the hybridization of narratives in the QAnon conspiracy, there remains the potential for OST to again become associated with a new story involving the UN and the NWO.



**The Area 51 Raid:** “Storm Area 51,” “Raid Area 51,” “Area 51 Basecamp,” and “Alienstock” refer to two festivals, one in Rachel, Nevada and the other in Hiko, Nevada, which occurred 19-22 September 2019. The original purpose of the Area 51 Events was to call attention to the U.S. Government’s purported ongoing cover-up of extraterrestrial life on earth. The section of the Nevada Test and Training Range known popularly as “Area 51” is allegedly a central part of this cover-up, where many UFO enthusiasts believe alien technology is secretly stored and tested.<sup>130</sup>

The Storm Area 51 Event began as a hoax on Facebook<sup>USPER</sup>. The hoax post “went viral,” and in a few months’ time, had as many as 2.5 million responses indicating intended participation. Further, as debates grew online over the seriousness of the event, interested persons began to indicate they were going to go to Area 51 and “raid the gate” as stated in the original post, despite understanding the event was intended as a joke.

**Analyst Comment:** Despite 2.5 million responses indicating the intent to attend the festival, only several thousand participated. Some attribute the low turn out to the aggressive law enforcement response leading up to the festival. The creators of the event were strongly advised by law enforcement to discourage attendees from attempting to penetrate the U.S. Government perimeter at the Nevada National Security Site; and the Air Force warned attendees not to breach the site.<sup>131</sup>

Several federal agencies, including OST, sent agents to support the security plan in response to Alien Fest, including OST. Although the conspiracy is not focused on OST, this event demonstrates how a conspiracy theory can still draw OST resources to support a U.S. Government response.
